RE: Support for H.R. 2117, FASTER Act of 2019

Dear Chairwoman Eshoo and Ranking Member Burgess:

I write on behalf of the American Academy of Allergy, Asthma, and Immunology (AAAAI) to thank you for including **H.R. 2117, the Food Allergy Safety, Treatment, Education, and Research (FASTER) Act** in the Subcommittee on Health hearing titled "Improving Safety and Transparency in America's Food and Drugs." Indeed, the FASTER Act would improve the health and safety of Americans living with food allergies and related disorders and we applaud your attention to this matter.

Established in 1943, the AAAAI is a professional organization with more than 6,700 members in the United States, Canada and 72 other countries. This membership includes board certified allergist/immunologists, other medical specialists, allied health and related healthcare professionals – all with a special interest in the research and treatment of patients with allergic and immunological diseases.

Food allergies trigger an overreaction of the immune system to a particular protein found in that food. Symptoms can occur when coming in contact with just a tiny amount of that food. Food allergy reactions can be life threatening, so people with this type of allergy must be very careful to avoid their food triggers.


AAAAI appreciates that the *FASTER Act* would advance recommendations from the National Academy of Medicine report "*Finding a Path to Safety in Food Allergy: Assessment of the Global Burden, Causes, Prevention, Management, and Public Policy*," including strengthening data collection on the prevalence of food allergies, and adding sesame to the list of allergens required to be listed on food labels, as well as providing flexibility for the Secretary of Health and Human Services to add any

other food ingredients determined by regulation to be a major food allergen. In addition, we support the provision of more information on patient experience data related to treatments for patients with food allergies and welcome a study of the economic costs of food allergies.
